Short description of the initiatives	<p>RYC represents young people and youth organizations in Romania in decision-making processes at national and international levels and supports their direct participation in these processes and in those at local and institutional/organizational levels, as well as increasing the capacity of young people and their organizations to influence the communities in which they live through legal instruments, influencing decision-making processes, working with young people, association in non-governmental organizations, unions and political parties, and business development.</p> <p>Currently, RYC brings together 22 federative structures, with a network of over 500 youth organizations in the country, being the only structure in Romania affiliated with the European Youth Forum and the World Assembly of Youth.</p>
Activities and methods implemented	<p>Lobbying and advocacy activities for the rights and interests of young people; Organizing conferences, symposiums, congresses, round tables, seminars, etc. on various areas of interest for young people; Conducting specific studies and research; Organizing information and awareness campaigns; Organizing training and professional development courses in various fields of activity and levels of training; Providing counseling and guidance in the field of academic and professional training; Providing expertise, consultancy, training and instruction services for individuals, non-governmental organizations or other interested legal entities; Developing and editing courses, manuals, scientific publications, information and training materials, magazines, albums, brochures, etc.; Recruiting, training and placing qualified personnel, especially young people, for interested legal entities in the country and abroad; Establishing and managing information and counseling points; Establishing and managing entrepreneurial development centers; Establishment and management of training centers and skills assessment centers.</p>
